

## Proposed Draft Multi Annual Programme

Ireland intends to use the funds as strategically as possible to maximise the added value arising from each project. Initially it is proposed that most of the monies available under both funds- ERF and EIF- will be used for integration related actions and in particular measures for implementing the Common Basic Principles for Integration of the Council of the European Union. This approach allows for support for the types of actions already supported under the current phase of the ERF. In 2009 it is proposed to expand the scope of activities under the EIF by seeking proposals which address Priority 3 of the Strategic Guidelines issued by the European Commission, e.g. capacity building, etc, at regional and local level. Actions which address Priority 4 of the Strategic Guidelines may also be co-financed. From 2010 to 2013 all of the Priorities will be addressed with main emphasis on integration activities under Priority 1 and capacity building, etc, under Priority 2.

With regard to actions under the ERF actions which support Ireland's Refugee Resettlement Programme will be co financed from 2008 and actions which address Priority 3 of the ERF Strategic Guidelines may be co-financed from 2009.

The tables below outline the manner in which it is proposed to allocate the funds received from the European Union in the period up and including 2013.
